

OneNebraska Federal Credit Union Scholarship

The OneNebraska Federal Credit Union (ONFCU) will be awarding a \$1,000.00 scholarship to three students who plan on attending an accredited university, college, junior college, vocational or business school.

ELIGIBILITY

1. Applicant must be a high school senior graduating in May 2026.
2. Applicants must be accepted at one of the accredited systems listed above.
3. Family members of Credit Union employees and officials are not eligible to apply.
4. All previous recipients of an ONFCU scholarship are ineligible for further scholarships.

ENTRY REQUIREMENTS

1. Applications must be submitted on the form provided in the spaces provided. It must be typed and stapled. Do not place in a binder.
2. Applicants must submit an official high school transcript.
3. Applicants must submit a copy of the letter of acceptance from the institution of choice.
4. Applicants must submit an essay on a topic chosen by ONFCU in 350 words or less.

JUDGING

1. Judging will be accomplished by a panel of impartial judges selected by ONFCU.
2. All entries must be submitted to ONFCU by April 3rd, 2026.
3. Scholarship recipients will be notified at the end of the school year.
4. All scholarship entries become the exclusive property of ONFCU.

ADMINISTRATIVE/AWARD PROCEDURES

1. Winners must begin studies within one year of the date of written notification of the scholarship award.
2. Scholarship funds will be paid to recipient and the institution within five months of the date of written notification of the scholarship award.
3. Funds are to be used only for tuition, room and board, or books and will be paid directly to the institution and the recipient.
4. Winner to provide photo and write up to be used for ONFCU advertising.

AUTHORITY OF OUFCU

1. ONFCU has the authority to amend any of the above rules to ensure fairness in awarding the scholarship.
